## 2023 RED POWER ROUND UP

### GOLF CART RENTAL OR USE WAIVER OF RIGHTS AND RELEASE OF LIABILITY

In consideration of being allowed to operate or use a golf cart at any location of the grounds of the 2023 International Harvester Collectors, Inc. and IHC Chapter 12 of Nebraska, Inc.'s "2023 Red Power Round Up" and related activities at Fonner Park, in Grand Island Nebraska the undersigned acknowledges, appreciates, and agrees:

1. That the risk of injury from the operation or use of a golf cart is significant, including the potential for permanent disability or death, and while particular rules, use of personal protective equipment and personal discipline may reduce this risk, the risk of serious injury or death does exist; and

2. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS**, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** or others, and I assume full responsibility for my use and operation of a golf cart; and

3. I willingly agree to comply with the stated and customary terms and conditions for use or operation of a golf cart at the Round Up. If, however, I should observe any unusual or significant condition or hazard during my use or operation of a golf cart, I will immediately terminate my use or operation of the golf cart and bring such condition or hazard to the attention of the nearest event staff member immediately; and

I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS** International Harvester Collectors, Inc., IHC Chapter 12 of Nebraska, Inc., Fonner Park, their directors, officers, officials, agents, servants, volunteers, employees, other participants, sponsors, advertisers, and the owners or lessors of the premises at the Round Up used to conduct the event (the "RELEASEES"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH**, or loss or damage to person or property, **WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, to the fullest extent permitted by law.

**I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.**
